## **CITY COUNCIL MEETING – JANUARY 4, 2023**

# Meeting held in-person at 50 Payson Avenue and remotely by Google Meet 6:00 p.m.

<u>Members Present:</u> President Homar Gomez, Vice-President Salem Derby, Owen Zaret, Koni Denham, Daniel Rist, David Meunier, Thomas Peake and Brad Riley were present in person. Councilor James Kwiecinski was present remotely.

### **Mayor Communications:**

5% Local Retirement COLA Option: Mayor LaChapelle had submitted a recommendation to allow the Retirement Board to increase the FY 2023 COLA for retirees up to 5%. This option is available due to legislation signed by Governor Baker in November. The increase would be retroactive to July 1, 2022. The Retirement Board had approved up to a 3% increase, but after waiting and watching the markets, it had been determined the additional 2% was well within financial projections. City Auditor Hetal Patel said the increase would have no monetary impact and would not impact the projection of the retirement system being fully funded by 2029.

There were no objections to voting on this motion at tonight's meeting as there is no appropriation involved.

On motion made by Councilor Rist and seconded by Councilor Peake it was **UNANIMOUSLY VOTED** (by roll call) in accordance with Chapter 269 of the Acts of 2022, the City Council approves implementation of the local retirement system option to increase the Cost of Living Adjustment (COLA) for Fiscal Year 2023 to 5% of the base amount specified pursuant to MGL Chapter 32, Section 103.
