

INVITATION TO BID CHERRY STREET GREEN INFRASTRUCTURE PROJECT

The City of Easthampton, the Awarding Authority, invites sealed bids from responsible and eligible bidders for the Cherry Street Green Infrastructure Project in Easthampton, MA in accordance with documents prepared by Fuss & O'Neill, Inc. The project consists of 2,000 lf of roadway reconstruction, new curbing and sidewalks, construction of traditional and green stormwater infrastructure, replace 2,000 lf of 8 inch water main, install 2,100 lf of 12 inch sewer pipe, replace water hydrants & gate valves, replace water & sewer services to the property lines of existing residents, restore the Cherry St. stormwater outfall and use bioengineering to stabilize a deteriorating streambank at Brickyard Brook.

THIS PROJECT IS BEING ELECTRONICALLY BID. NO HARD COPIES OF THE BID DOCUMENTS WILL BE DISTRIBUTED BY THE CITY AND NO HARD COPY BIDS WILL BE ACCEPTED. All bids are subject to the provisions of MGL c. 30, s 39M as amended, and MGL C 149 s 26 to s 27H inclusive as amended. Minimum wage rates must be paid as required by MGL and the provisions of the federal Davis-Bacon Act. General bids shall be received electronically until 4PM, Wednesday, April 6, 2022 at www.biddocsonline.com at which time they will be publically opened, forthwith.

General bids shall be accompanied by a bid deposit no less than 5% of the greatest possible bid amount and made payable to the City of Easthampton. The successful bidder shall provide to the awarding authority a 100% payment and performance bond and certificate of insurance as outlined in the bid documents.

A mandatory pre-bid conference shall take place at 10AM on March 22, 2022 in Conference Room B (basement) of the Easthampton Municipal Building at 50 Payson Avenue, Easthampton, MA. Bid Forms, Documents and Plans can be viewed electronically or a hard copy requested at www.biddocsonline.com. Plan deposits can be paid electronically or by check. There is a plan deposit of \$50 per set (maximum two sets) payable to Biddocsonline Inc. Plan deposits to be refunded for up to two sets of plans for general bidders and two sets for sub-bidders upon return of the plan sets in good condition within 30 days of bid opening.
